3. The required Marginal Open spaces as per DCPR requirements should be kept open and obstruction free at all time.



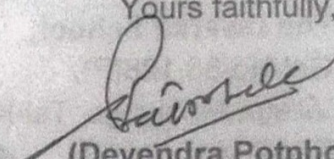
